

**Ordinance Number: 30-21**

See April 12, 2021 Minutes

AN ORDINANCE TO CHANGE THE DATE, TIME AND PLACE FOR THE REGULAR MONTHLY MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE VILLAGE OF ELIZABETH, LOUISIANA.

**BE IT ORDAINED** by the Mayor and Board of Aldermen for the Village of Elizabeth, Louisiana, who met in regular session and enacted the following **Ordinance Number 30-21** which shall read as follows:

**Section 1**

The regular meeting of the Mayor and Board of Aldermen of the Village of Elizabeth shall be held on the Second Monday of each month at the hour of 5:30 p.m. at the Elizabeth Community Center located at 210 East Main Street, Elizabeth, LA.

**Section 2**

Be it further ordained that all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent the conflict with this Ordinance.

**Section 3**

This ordinance shall become effective upon signature by the Mayor, or in the event of a veto, upon override.

**Section 4**

If any provision of this Ordinance and the application thereof is held invalid, such invalidity shall not affect other provisions, items, or applications of this Ordinance which can be given effect without the invalid provisions, items, or applications, and to this end, the provisions of this Ordinance are hereby declared severable.

Ordinance introduced on the 9<sup>th</sup> day of March, 2021 by Council member Kelly Stalsby.

Notice of the proposal of this Ordinance was published in the official journal on the 8<sup>th</sup> day of April 2021.




