**AN ORDINANCE OF THE VILLAGE OF ELIZABETH TO AMEND THE MAYOR'S SALARY
BY INCREASE, CONSIDERED FULLTIME AND TO PROVIDE FOR RELATED MATTERS**

BE IT ORDAINED, by the Mayor and the Board of Aldermen of the Village of Elizabeth, Louisiana, that the Code of Ordinance, Village of Elizabeth, is hereby enacting Amendment to Ordinance No. 18-19 of the Code of Ordinances, which shall read as follows:

BE IT ORDAINED, that Ordinance 18-19 is hereby adopted with regard to the salary paid to the Mayor. Said salary shall be increased, from \$1600.00 to \$1800.00, effective September 3, 2019, as follows:

Mayor: monthly gross of \$1800

BE IT FURTHER ORDAINED that the office of Mayor for the Village of Elizabeth will be considered as full time until further consideration of the Board of Aldermen.

BE IT FURTHER ORDAINED that this ordinance shall become effective September 3, 2019, upon signature of the Mayor; or, if not signed or vetoed by the Mayor, upon expiration of the time for ordinances to become law without signature by the Mayor.

BE IT FURTHER ORDAINED that the Mayor's salary shall be reduced to \$1600 gross per month at the beginning of the next term of office.

BE IT FURTHER ORDAINED that if any provision or item of this ordinance of the application thereof is held invalid, such invalidity shall not affect other provisions, items, or applications of this ordinance which can be given effect without the invalid provisions, items, or applications, and to this end the provisions of this ordinance are hereby declared severable.

BE IT FINALLY ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed.

THIS ORDINANCE 18-19A1 was introduced on the 4th day of February, 2020.


