AN ORDINANCE PROVIDING FOR UTILITY RATES FOR UTILITIES PROVIDED BY THE VILLAGE OF ELIZABETH

BE IT ORDAINED, by the mayor and the Board of Aldermen of the Village of Elizabeth, Louisiana, that the following Ordinance Number 14-18D is hereby enacted to read as follows:

Section 1

BE IT ORDAINED, by the Council of the Village of Elizabeth, Louisiana, in a regular session convened, that the Council hereby amends Ordinance 14-18C to become Ordinance 14-18D of the Village Code concerning water rates and sewer rates for the Village of Elizabeth's water and sewer customers.

Section 2

BE IT FURTHER ORDAINED that the water and sewer rates of the Village of Elizabeth's water system are to be changed as shown on the rate charts which are attached hereto and made a part hereof.

Section 3

BE IT FURTHER ORDAINED that the variable rates in the attached rate charts shall adjust every year beginning January 2019 and adjusting every January thereafter in an amount equivalent to the unadjusted 12-months percent change in the CPI for All Urban Consumers (CPI-U): U.S. city average as published by the Bureau of Labor Statistics.

Section 4

In addition to the costs outlined in the foregoing sections, all customers shall be charged the following re-read fees, should they request a re-read of their meter:

In Town Customers: \$15.00 Out of Town Customers: \$25.00

A customer will not be charged a re-read fee if an error is discovered on the part of the Village of Elizabeth. An error occurs when a customer's meter is read in a mistaken amount upon its first reading in any given month.

Section 5

BE IT FURTHER ORDAINED that this ordinance shall become effective upon signature of the mayor.

Section 6

BE IT FURTHER ORDAINED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items, or applications of this ordinance which can be given effect without the invalid provisions, items, or applications, and to this end the provisions of this ordinance are hereby declared severable.

Section 7

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed.

Said Ordinance having been introduced on the 10th day of November, 2020 by Notice of Public Hearing having been published on the 6th day of November, 2020, said Public Hearing having been held, title having been read and Ordinance considered, on motion by Angela Smith and seconded by Kelly Stalsby to adopt the Ordinance the 1st day of December, 2020.
