

Ordinance Number: 15-19A4

AN ORDINANCE TO MODIFY THE SALARY FOR THE VILLAGE OF ELIZABETH CHIEF OF POLICE FOR THE NEXT TERM AND TO PROVIDE FOR RELATED MATTERS.

BE IT ORDAINED by the Mayor and Board of Aldermen for the Village of Elizabeth, Louisiana, who in lawful session convened, and elected to amend Ordinance No. 15-19A3 as follows:

Section 1

For the term of January 2027 through December 2030, the salary of the Chief of Police for the Village of Elizabeth shall be decreased as provided herein.

Section 2

At the time of this amendment, the salary of the Chief of Police for the Village of Elizabeth was set at ONE THOUSAND SIX HUNDRED DOLLARS (\$1,600.00) per month, with an additional SIX HUNDRED DOLLARS (\$600.00) per month in State Supplemental Pay if the Chief of Police was POST CERTIFIED.

Section 3

For the term of office beginning January 2027 and ending December 2030, the position of Chief of Police for the Village of Elizabeth shall be a part-time position, and the rate of pay for the position shall be (EIGHT HUNDRED DOLLARS) \$800.00 per month. Also, a POST CERTIFIED officer will receive (SIX HUNDRED) \$600.00 per month in Supplemental Pay from the State of Louisiana. This \$600.00 Supplemental Pay must be paid to the Village of Elizabeth and then issued to the POST CERTIFIED Chief of Police.

Section 4

This ordinance shall become effective upon signature by the Mayor or, in the event of a veto, upon override.

Section 5

If any provision of this Ordinance, or the application thereof, is held invalid, such invalidity shall not affect other provisions, items, or applications of this Ordinance which can be given effect without the invalid provisions, items, or applications, and to this end, the provisions of this Ordinance are hereby declared severable.

Section 6

All ordinance or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Said ordinance having been introduced on the 8th day of September 2025 and notice of Public Hearing having been published on the 18TH day of September 2025. Public Hearing having been held, title having been read and ordinance considered the 13th day of October 2025.

The above and foregoing Ordinance was read and called for a vote by the Mayor at a meeting of the Village Council called for said purpose on the 13th day of October 2025.
